Non-Resident Guided Antlered Mule Deer Hunt Application Attestations

Pursuant to NAC: 4231(2), Master Guides who apply for the Non-Resident Guided Antlered Mule Deer Hunt on behalf of their clients must submit the following attestations to the Department of Wildlife by the end of the application period. (For use in this document, application period includes any time during the application period up to the day before the tag draw).

NAC 502.4231 Electronic application for tag; required statements. (NRS 501.105, 501.181, 501.337, 502.030, 502.148, 502.160, 502.175, 502.250)

1. In addition to the provisions of NAC 502.199 and 502.4175, a person who wishes to obtain a restricted nonresident deer tag must submit an electronic application provided by the Department.

2. In addition to the provisions of subsection 1, if an application is submitted by a master guide for the applicant, the application must include the following statements which must be acknowledged and attested to by the master guide: (a) A statement indicating that the applicant is entitled to the issuance of a restricted nonresident deer tag pursuant to the laws of this State;

(b) A statement indicating that the master guide has power of attorney to sign the application on behalf of the applicant; and

(c) A statement indicating whether the master guide will be guiding on federally administered public lands and, if so, indicates that the master guide possesses a valid special use permit issued by the federal land management agency having jurisdiction within the wildlife management area or unit for which the applicant is applying.

INSTRUCTIONS: Master Guide: Fill or check as appropriate. Return the completed form to the Nevada Department of Wildlife. Signed Electronic copies and printed, signed paper copies will be accepted if received prior to the date of the draw. Electronic copies may be sent to: NDOWguides@ndow.org.
