IMPORTATION INSPECTION

**LEGAL AUTHORITY: NRS 503.595; NAC 503.560** 

**INSPECTION REQUIREMENTS:** The Department may require an inspection of any shipment or wildlife, aquatic life, spawn, eggs, or young of any of them brought or shipped into the State of Nevada.

**INSPECTION OF SHIPMENT – WILDLIFE**: Upon receipt of an Importation Permit application, the Department shall notify the permittee of the time and place of an inspection of wildlife to be imported, if one is required.

### **INSPECTION OF SHIPMENT - LIVE FISH, LIVE BAIT, AQUATIC BAIT:**

Any person receiving, bringing, having brought or shipped into the State of Nevada with the destination therein, any live fish or aquatic life, shall notify the Department at least five days in advance of each such shipment. The notice shall give the date, destination of the shipment, approximate time of arrival at the destination, and the route of travel. If changes in the transportation schedule occur, the person shall notify the Department prior to 24 hours before the date and time previously established.

The Department shall notify the person of the time and place if an inspection of the shipment is required.

## APPROVAL BY THE DEPARTMENT:

An Inspection Report will be completed at the time of inspection. If any shipments are determined by the Department inspector to be detrimental to the best interests of the State of Nevada, such shipments shall either be destroyed or the permittee or his representative shall remove them from the State of Nevada via his entering route or route designated by the inspector.

A \$25 inspection fee may be charged for each inspection with one exception. If two or more shipments originate from the same source and arrive at the same destination at the same time, only one \$10 inspection fee shall be charged; such fee to be prorated equally between the importers involved.

**REJECTION OF SHIPMENT:** The permittee shall be notified by the Department in writing within 15 days of the reason for such rejection.
