RESIDENT DISABLED VETERAN SPECIALTY COMBINATION HUNTING AND FISHING LICENSE - \$15.00

CONDITIONS: The Department shall issue a specialty combination hunting and fishing license, upon satisfactory proof of the requisite facts to any actual bona fide resident of the State of Nevada who has incurred a SERVICE-CONNECTED disability which is considered to be 50 percent or more by the United States Veterans' Affairs and has received upon severance from an honorable discharge or certificate of satisfactory service from the Armed Forces of the United States.

Attach your Benefit Summary – Percentage Letter from the Department of Veterans' Affairs certifying 50 percent or more service-connected disability as proof of eligibility. If you do not have a copy of the letter, you can obtain one at www.ebenefits.va.gov.

RESIDENCY: Resident means any person who is a citizen of the United States and who has been actually present in the State of Nevada for 6 months immediately preceding his application and who intends to make Nevada his/her permanent home. Please attach a copy of your Nevada Driver's License or photo ID.

HUNTER EDUCATION: Attach a copy of the certificate of hunter education administered by state or Canadian provincial wildlife management agency if you were born after January 1, 1960. NRA or military certificates are not acceptable.
